BIOGRAPHY

BREWER, David J. — Associate Justice, Supreme Court of the United States, 1889-1910; U. S. Cir. Judge, 8th Jud. Cir., 1884-89 (appointed Cir. Judge by President Arthur).

b. Smyrna, Asia Minor, June 20, 1837 (died Mar. 28, 1910, Wash., D.C.). Son of Rev. Josiah (who had gone to Turkey as a missionary in 1830) and Emilia (Field) B.; nephew of late Mr. Justice Stephen J. Field; A.B., Yale, 1856, A.H., 1859; LL.B., Albany Law Sch., 1858; LL.D., U. Ia., 1884, Washburn Coll., 1888, Yale, 1891, U. of Wis., 1900, Wesleyan, 1901, U. of Vt., 1904, Bowdoin, 1905; m. Louise R. Landon, Oct. 3, 1861 (died 1898); m. 2d Emma Miner Mott, June 5, 1901. Began practice of law, Leavenworth, Kans., 1859; U.S. commr., 1861-62; judge probate and crim. courts, Leavenworth Co., 1863-64; judge Dist. Ct., 1865-69; co. atty., 1869-70; justice Sup. Ct., Kans., 1870-84. Mem. Venezuelan Boundary Commn., 1896; mem. British-Venezuelan Arbitration Tribunal, 1899. Prof. corp. law, George Wash. U. Pres. Universal Congress of Lawyers and Jurists, La. Purchase Expn. St. Louis, 1904. Pres. Associated Charities, Wash., D.C.; Vice-Pres., American Missionary Assn. **Author:** *The Pew to the Pulpit*, 1897; *The Twentieth Century from Another View Point*, 1899; *American Citizenship*, 1902; *The United States a Christian Nation*, 1905. Congregationalist. Republican.

SUTHERLAND, George — Associate Justice, Supreme Court of the United States, 1922-1938.

b. Stony Stratford, Buckinghamshire, Eng., Mar. 25, 1862 (died July 18, 1942, Stockbridge, Mass.). Son of Alexander G. and Frances (Slater) S.; Brigham Young Academy (now Brigham Young U.), 1881; law student, U. Mich., 1882-83; LL.D., Columbia, 1913, U. Mich., 1917, George Wash., 1921, Brigham Young U., 1941; m. Rosamond Lee, June 18, 1883; children—Emma Sutherland Hempstead, Philip Lee, Edith Sutherland Bloedorn. Admitted to Mich. bar, 1883; began law practice at Salt Lake City, Utah, 1893. Mem. first Utah Senate, 1896; mem. 57th Congress (1901-03), Utah (declined renomination); while in Congress helped write the Reclamation Act; U.S. senator, 1905-17. Senatorial achievement: revision and codification of fed. crim. statutes which became law in 1910. Pres., Amer. Bar Assn., 1916-17; chmn. Advisory Com. for the Washington Armaments Conference, 1921; represented U.S. in arbitration proceedings before The Hague Tribunal, 1921-22. **Author:** *Constitutional Power and World Affairs*, 1919. Republican.

VAN DEVANTER, Willis — Associate Justice, Supreme Court of the United States, 1910-1937; U. S. Cir. Judge, 8th Jud. Cir., 1903-10 (appointed Cir. Judge by President T. Roosevelt).

b. Marion, Ind., Apr. 17, 1859 (died Feb. 8, 1941, Wash., D.C.). Son of Isaac and Violetta Maria (Spencer) V.; Ind., Asbury (now DePauw) U., 1875-78; LL.B., Cincinnati Law Sch., 1881; LL.D., DePauw U., 1911, U. of Cincinnati and Yale, 1927, U. of Wyo., 1933, Coll. of Charleston, S.C., 1935; m. Dollie Paige Burhans, Oct. 10, 1883 (died 1934); children—Isaac Burhans, Winslow Burhans. Practiced law, Marion, Ind., 1881-84; then at Cheyenne, Wyo.; commr. to revise Wyoming Statutes 1886; city atty., 1887-88; mem. Territorial Legislature and chmn. of judiciary com., 1888; chief justice of Territorial Sup. Ct. of Wyo., 1889-90; chmn., Rep. State Com., 1892-96; mem. Rep. Nat. Com., 1896-1903; asst. atty. gen. of U.S. in charge of Indian and public land

cases in the Dept. of Interior, 1897-1903. Chief draftsman of the Judiciary Act of 1925, and of the revised Rules of Court which implemented it; chmn. of committee of justices to supervise a receivership of lands on the Oklahoma-Texas border growing out of a boundary dispute. Mem. Intl. Commn. which arbitrated and determined Canadian Claims for sinking vessel "I'm Alone" by Coast Guard, 1934-35. Prof. equity pleadings and practice, 1898-1903, equity jurisprudence, 1902-03, *Columbian* (now *George Washington*) U. Methodist. Republican.

WHITE, Byron R. — Associate Justice, Supreme Court of the United States, 1962—

b. Fort Collins, Colo., June 8, 1917. Son of Alpha Albert and Maude E. (Burger) W.; B.A., with honors, U. Colo., 1938; Rhodes Scholar Oxford (Eng.) U.; LL.B., magna cum laude, Yale Law Sch.; professional football player with Pittsburgh Steelers, 1938 season, with Detroit Lions, 1940 and 1941 seasons, named to National Football Hall of Fame, 1954; m. Marion Stearns, June 15, 1946; children—Charles, Nancy. Law Clerk, Chief Justice Fred Vinson, U.S. Sup. Ct., 1946-47; atty., Lewis, Grant and Davis, Denver, 1947-60; dep. atty. gen., U.S., 1961-62. Served Naval Intelligence in South Pacific, World War II (lt.) Mem. Phi Beta Kappa, Phi Gamma Delta, Order of Coif. Democrat.
